

## Public Hearing for 1465 Greig Road Application Postponed

At the meeting on September 7, Council received correspondence from the proponent, District Developments Corp, regarding the application at 1465 Greig Road (File 3360-PZN032). The correspondence dated September 6, requested Council postpone a public hearing scheduled for September 19.

Council approved postponement of the public hearing until further notice and directed staff to forward the information to the November 21 Council meeting for discussion by the newly elected Council members on options for a rescheduled public hearing date.

On behalf of District Developments Corp, we would like to formally request that our Public Hearing for application number 3360-PZN032 scheduled for September 19, 2022 be postponed to a future Council meeting in December. This is simply because of availability of key consultants on September 19 and there are a few items that we are spending additional time on to ensure we can fully address any questions at the Public Hearing. These include, but are not limited to, evaluating the recently released floodplain analysis as well as further developing a trail network plan and associated phasing.

We are not concerned about any technical aspects changing this proposal, but we feel we owe the process, ourselves, City staff, the Mayor and Council and members of the public appropriate due diligence in answering these questions. In an ideal world, all of this analysis would be complete; however, consultant capacity and summer work schedules have not allowed this to happen. Our consultant experts are in high demand and unfortunately scheduling has been an issue. Again, this is in an effort to make sure all questions that may come up at the Public Hearing can be fully and accurately addressed.

We are working diligently to complete this analysis in the coming months and we will be ready for a Public Hearing in December. We kindly request that Council consider us for a Public Hearing date on December 5, 2022.
